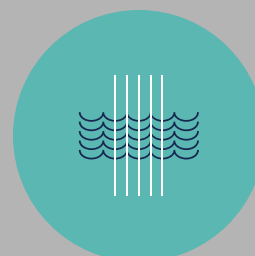
Your custom project is designed, and plans
